## Merry Christmas, Friends,

It was fun to watch Kristin and Donna who hadn't seen each other in about 30 years. We live in such a beautiful state,



and it's fun to share it with visitors as we discover it ourselves. We spent a long weekend at the Cove in late June

where our friend, Alex McFarland was leading a weekend of Bible study. We took an afternoon to drive to Mt. Mitchell, the highest point east of the Mississippi River.

In early September, we spent a week in Wisconsin. We enjoyed the sights and sounds and tastes of Door County for a few days, and

then spent a few days with Dennis's brother, Dale and his wife Staci. We went to the baby shower for their son, Wes, and Jessica. We'll all welcome their baby girl later this month. In October, we had meetings at CEF headquarters in Missouri. Our niece, Kristin and nephew, Andrew came with their families, and





met us for the weekend. We visited the St. Louis Zoo, and had wonderful Italian food at "The Hill," St. Louis's Italian community. We are so thankful to be part of the lives of their children, our great nieces and nephews, who range in age from 17 to 3.



We detoured through Dallas on our way home from St. Louis and visited with Darwin and Fauhn Schierer. We rode The Texas State Railroad roundtrip from Palestine to Rusk and back. It was overrated, but still fun.



We had a wonderful Thanksgiving at our house with Julie and Shea, and Shea's parents from South Carolina. Our younger daughter, Jennifer, was not able to be with us. She is doing well, living in Raleigh and working in the home building industry.



My mom turned 84 in April, and we had a celebratory luncheon with a group of her lady friends. Mom still lives alone in her own home, and is active. Her home as about 1.5 hours from ours, and I try to go about once each month and visit with her for a few days.

Dennis remains active with the NC Association of CPAs, and continues to offer consulting and assistance for nonprofit organizations and Christian ministries, missionaries, chaplains, and pastors. He's gone international this year, as he has received requests for assistance from individuals in at least three countries outside the US. This ministry brings us in touch with so
